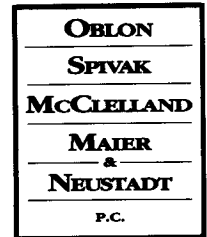
Dear Mr. Scott:

This is further to our letter dated October 5, 2004 (copy enclosed).

We have not received a response from you and improper references to the *BARDEX* mark used to refer to enema equipment continue to appear in the several stories posted within <http://protovision.textfiles.com/sex/EROTICA/>. In particular, inaccurate references to the *BARDEX* appear in the stories titled *An Interesting Saturday Night, Part 5, Lori's Last Day* and *Pamela's Story*.

As explained previously, the federally registered *BARDEX* trademark only identifies C. R. Bard, Inc. medical products, namely urological catheters, which require a prescription and are to distributed and/or used under a physician's supervision. Use of our client's trademark to identify enema equipment in erotic fiction is likely to cause confusion and dilute the value of the *BARDEX* trademark in violation of trademark laws. Accordingly, we request you revise the text of the stories to refer to enema nozzle, enema balloon, enema bulb, or some other generic term, and discontinue the use of the *BARDEX* trademark.

If we do not hear from you or your attorney by **December 1, 2004**, and if improper use continues, we will consider your failure to cease using the mark as willful infringement and dilution and we will contact your hosting site and/or registrar to make sure you receive proper notification of the continued problem.

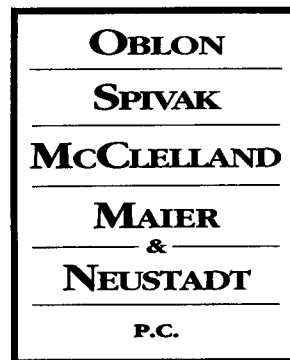

Dear Mr. Scott:

Our firm represents C. R. Bard, Inc. of Murray Hill, New Jersey, and its related company, BCR, Inc., owner of the federally registered trademark BARDEX. The BARDEX trademark has been registered in the United States since 1951 in connection with various medical products, including urological catheters (U.S. Trademark Registration No. 543,922).

We learned of the improper and unauthorized use of our client's mark in connection with your website. Enclosed are sample printouts showing the improper and inaccurate references to the BARDEX mark appearing within the following stories:

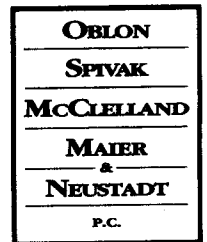

References to *BARDEX nozzle*, *Double BARDEX*, *BARDEX balloons*, and *BARDEX bulb* are likely to cause confusion as to the origin of the products or services identified and dilute the value of our client's federally registered mark in violation of the trademark laws. The BARDEX mark identifies our client's medical products and is not related to enemas, rectal catheters or other enema equipment. BARDEX only identifies C. R. Bard, Inc. medical products, namely urological catheters, which require a prescription and must be distributed and/or used under a physician's supervision. We are concerned that the improper references to our client's mark and product in connection with enema equipment and sexually explicit stories are likely to mislead consumers, resulting in misuse and possible injury. Accordingly, we request you revise the

stories to refer to a balloon nozzle, enema bulb or some other generic phrase, without referring to our client's trademark.

We would like to resolve this matter quickly and amicably, without resort to the courts, if possible. To that end, we hereby demand that:

1. Each reference to the BARDEX mark be **immediately** deleted from your website, in the stories posted in the archive appearing within the directory, and any other materials distributed by you.
2. Each use of the BARDEX mark in hidden text, source code language, and on search engine indices and lists referring to your website must be **immediately** discontinued.

We will continue to monitor the story archive on your website to determine if each reference to the BARDEX mark has been removed.

If the references to our client's mark are not removed and we do not hear from you or your attorney by **October 20, 2004**, then we will recommend that our client institute a lawsuit, without further notice, and that damages to the fullest extent provided by law as well as costs associated with the lawsuit, be demanded.

Kay walked behind Susie to perform the same test. I heard Susie gasp again as she pumped still more air into the balloons.



"Don't blow it up too much or there won't be enough room later." Sabina and Kay laughed as they detached the bulbs from their ports and put them back in the cabinet.


"I'll keep that in mind Sabina. It will be very useful in training some of my more unruly slaves."

It should be ready by the time you're finished, so just put on the robes we left for you and come back to join us Then we can all have some dinner and discuss our future plans for the two o you."

When we got upstairs, Susie gently rubbed her mistreated tits. "God, my nipples hurt. I love my Mistress a lot, but I hate it when she makes me wear those blasted clamps. One time, she made me wear them under my bra while we were at a dinner party. They hurt like hell and I couldn't concentrate on anything else. Even though I wore a shawl to cover their

X-rated movie houses in the late seventies. It has a number of well-known porno stars, led by Jamie Gillis, who plays the role of the Enema Bandit. All the acting is quite good, and since the movie is based on a real series of events, the plot hangs together very well. The video quality should also be also better than usual, because it's a transfer from film.

``Waterpower'' is a fairly violent movie, both because the actual Enema Bandit forcibly administered enemas to his victims, and also because D/S seems to be a hallmark of Jamie Gillis, who is unquestionably into what he is doing. There are 4 enema scenes, all arousing:

(1) The Enema Bandit goes to an enema parlor and observes a client playing enema-doctor to a bound patient. With his ``nurse's'' help he administers a forced-enema to the bound patient in a hospital setting, using a bardex nozzle. She then expels into a bedpan, although you don't see much of that. ←

(2) The Enema Bandit breaks into the apartment of his neighbor, who has ``dirtied'' herself by having sex, and forces her into the bathroom where he has anal sex with her (I'm pretty sure of this, although the scene is neither long nor detailed). He then has her crouch down by the toilet to receive an enema for purification, which she expels into the bathtub (again, not too explicitly filmed).

(3) The Bandit breaks into the apartment of two lesbians, has anal sex with one of them (short scene), and then gives them both enemas while they are tied standing-up in the shower.

→ (4) A policewoman trying to catch the Bandit succeeds in luring him to her apartment but, while she is out of the room, he discovers her real identity. When she returns he ties her up, explains at some length that she must have wanted the case because she secretly likes enemas, and then leads her to the bathtuburifin which she is placed, bottom-upwards. He squats behind her and administers an enema using a straight-plastic nozzle which he periodically removes, presumably so that we can witness the water coming back out (which we do see). He also penetrates her anally at one point during this procedure. The scene then fades out, only to return with the Bandit preparing to administer an enema with a bardex nozzle. He leaves the apartment while the water is going in, and the policewoman is eventually rescued by a policeman friend.

I have to say that this is a movie that is near and dear to my heart, because I grew up in the town where the REAL enema bandit struck, I was in junior high at the time and the reports in the paper (not very explicit obviously) gave me an almost continual hard-on. And this

Enema, Ms. Marilyn's Rectal Irrigation, Nurse's Prep, Wendy's G.I. Prep) have a ``visiting nurse'' enema scenario, which doesn't really work for me. I like the idea of a nurse/patient enema that is given in a hospital setting, where the patient is completely at the mercy of the nurse, well away from the comfort (slight though it may be) of her own home, unable to protect or defend herself in any way from the inevitable administration of the enema. There's obviously a D/S theme there, and in keeping with that my favorite Tyler films are, ``A Mother's Touch'', ``In Desperate Need'', ``Revenge Enema'', and ``Stacey Learns Her Lesson'', all of which involve spanking and D/S. Don't get too excited about the spanking though--these people are into enemas, not spanking, so the spankings ar just OK. If you want real spanking try Nu-West and related companies.

Finally, on to the subject of expulsion. Yes, most of these videos do indeed show actual expulsion--quite viewable--of the enema. The model squats with her back to you, over a bedpan or plastic bucket, the nozzle is pulled out, and she lets fly. This may sound gross, but it isn't. What comes out is basically as crystal-clear as perrier water (without the benzene, I hope for the model's sake). It would be interesting to see a video of the models PREPARING for a shoot--for the water to end up being that clean I would guess they take three or four enemas (at least) before they start filming. No brown showers here.

A Mother's Touch (30 min)

``Carla, a voluptuous blonde, returns from her date to find her mother waiting and upset because she stayed out so late and took her car. Mother gives her a good over-the-knee spanking plus a two quart enema using the Davol Paris Red combination bag and black douche nozzle. Tap features very good spanking scene. Carla expels into the john.''

``Voluptuous'' means somewhat overweight (she's young enough to carry it off). Video quality adequat story line and acting excellent!

High-Volume Enema (13 min)

``Short--but to the point! Sandy finds herself in need of a G.I. series, and to prevent possible embarrassment from her fellow workers doing the prep, she returns to Wendy for help [see Wendy's G.I. Prep.]. Sandy, however, does it all in one shot! She has Wendy prepare a full, four-quart enema using the red Sherema bag and bardex nozzle. Wendy's a little new at giving, making the insertion of the nozzle long and detailed. With Sandy wearing her white undergarments only, she takes ALMOST the entire four quarts prepared by Wendy. Tap features full bag preparation, excellent

close-ups, partial intake expelled into bedpan.''

In Desperate Need (30 min)

``Vicki and Suzanne have a scene in the bedroom. Vicki is constantly complaining of a tummy-ache from all the junk food she ate so Suzanne decides that what she really needs is a good spanking and an enema. She gives her a 2.5 quart enema using the red open-top bag and a double-bardex nozzle. Vicki expels into the john. Average spanking scene; good close-ups. [see also Revenge Enema]''

Both models have a sense of humor, which actually adds to the eroticism since it makes their acting less wooden. The video quality could be better, and there are some technical glitches (mainly radio noise), but I liked it and its companion, ``Revenge Enema.''

Ms. Marilyn's Rectal Irrigation (35 min)

``Ms. Marilyn starring in her FIRST video tape with Nurse Amy. Marilyn seems to need an operation and Nurse Amy is just the one to prepare her for it. Amy, clad in full uniform, arrives at Marilyn's place early to get started. First, she takes her pulse, etc., and then her first rectal temp. In need of a complete clean-out, Amy prepares the first of two enemas for Marilyn. The first, using an open-top, white Victorian bag with white tubing and white douche nozzle. On her right side, Marilyn sucks the entire contents. After expelling the first, Amy then prepares her second and more powerful enema using a 2.5 quart open-top red Davol bag, amber latex tubing and 32 french scale rectal tube. After taking her temp. again [rectally, as if there were any doubt], Amy begins the insertion of the rectal tube and starts the flow of water. The entire length is inserted and the entire bag is emptied into Ms. Marilyn. With a full tummy, Amy helps her into the bathroom where she expels. Incidentally, Marilyn is clad in an original, authentic hospital jonny [the slit gown with easy-access to the patient's rear-end]. Definitely a winner for her first (of many). Video quality, good, video content is excellent, some audio noise from radio transmitter interference but very audible regardless.''

Nurse's Prep. (40 min)

``Nurse Anderson shows up early AM and prepares Lisa for a G.I. series. Lisa is given a series of three enemas, all from a clear plastic bag, totalling about three quarts, and using a white plastic tip, a colon tube, and a double bardex. Lisa expels into the john after each one. Tap features excellent close-ups of insertion.''

"Just wait a minute, Susie. We have to get Pamela undone first." With that, Kay slapped the hinged handcuffs on Susie's wrists as she continued to hold her gut. "We're trying to foster a spirit of cooperation between you two, so we want to be certain that you'll have to help each other remove the enema retention catheters. Sabina will see to the Foleys herself."

Susie's wrists were now helplessly imprisoned in front of her. There was no way she would be able to reach around to remove the Bardex. ←

Kay hit the remote button to lower me to the floor, and turned to assist Sabina who was already busy releasing me from my bondage.

Finally, I stood there wobbling on my heels, grabbing my gut, and anxiously shifting my weight from one foot to the other, when Sabina manacled my wrists together with another pair of Smith & Wessons. "You heard what Kay said to Susie. You're going to have to remove her Bardex...and she's going to have to remove yours. Here are the squeeze bulbs. You'll have to attach it to the port on the catheter in order to deflate the balloons. Before you go though, let me rid you of those Foleys." →
